In the event the installation is used for other purposes, the installation shall be removed at my own costs and CLP Power reserves all rights to recover any loss, damages, costs, charges and expenses arising out of or in connection with such use of the installation.

3. PERSONAL INFORMATION COLLECTION STATEMENT

3.1 Personal Data We Hold

3.2 Purpose of Collection

CLP may use the personal data held by us for the supply of electricity to you and any directly related purposes. CLP may also use such personal data:

- to open, maintain and terminate accounts
- to supply you with services, facilities and goods you requested
- to respond to and follow up on your enquiries
- to process billing, payments and sales orders
- to conduct customer surveys
- to conduct research and perform statistical analysis
- to enable you to better understand your energy usage
- to gain an understanding of your energy needs
- to provide energy services, hints and tips on energy conservation
- to notify you of changes to our services that may affect you
- to develop new products and services
- to conduct direct marketing activities (including making appeals for non-profit organisations that may or may not be related to CLP)
