

1) I submitted a FiT application before the new FiT rates came into effect, but it has not been approved. Will my provisional FiT rate be affected?

i) [If complete FiT Application Form and Preliminary Supporting Documents have been submitted]

When your application is approved, your provisional FiT rates will follow the prevailing rates published on the CLP website on the day when your FiT Application Form and Preliminary Supporting Documents were received by CLP. If your application was submitted before the new FiT rates came into effect, you are entitled to the FiT rates before adjustment. Please be reminded that your renewable energy (RE) system needs to be connected to CLP grid within a designated period of time.

ii) [If the FiT Application Form and Preliminary Supporting Documents have been submitted but are incomplete]

When your application is approved, your provisional FiT rates will follow the prevailing rates published on the CLP website on the day when your FiT Application Form and Preliminary Supporting Documents were received. If you are able to provide the required documents within one month from the issuing date of the reminder letter, your provisional FiT rates will be the FiT rates before adjustment. Please be reminded that your RE system needs to be connected to the CLP grid within a designated period of time.

If you are unable to provide the required documents within a month, your provisional FiT rates will be the new FiT rates.

2) I submitted the FiT application before the new FiT rates came into effect. Preliminary assessment indicated that network reinforcement would be required for my application to be approved. Will my provisional FiT rate be affected?

i) [If the customer has not responded to the network reinforcement proposal]

If you respond to the network reinforcement proposal within one month after communicating with our Account Manager, your provisional FiT rates will be the FiT rates before adjustment.

If we do not receive any reply from you within one month, we will issue a reminder letter. If we still do not receive any reply from you for another one month, your application will be invalid.

If you are interested in taking part in the FiT scheme in future, resubmission of the FiT Application Form and Preliminary Supporting Documents is required and your provisional FiT rates will be the prevailing FiT rates at the time of your future submission.

ii) [If the customer has not signed the Network Reinforcement Condition Letter and/or not paid the deposit]

If you submit the signed Network Reinforcement Condition Letter and/ or pay the deposit within the designated date, your provisional FiT rates will be the FiT rates before adjustment.

If you are unable to provide the signed Network Reinforcement Condition Letter and/ or unable to pay the deposit within the designated date, your application will be invalid.

If you are interested in taking part in the FiT scheme in future, resubmission of the FiT Application Form and Preliminary Supporting Documents is required and your provisional FiT rates will be the prevailing FiT rates at the time of your future submission.

iii) [If the customer has signed the Network Reinforcement Condition Letter and/or paid the deposit or the network reinforcement is in progress]

Your provisional FiT rates will be the FiT rates before adjustment.

3) I submitted the FiT application before the new FiT rates came into effect, and it has been approved, but the RE system has not been connected to the CLP grid. Will my provisional FiT rates be affected?

i) [If no technical documents have ever been submitted by the customer after CLP issuing the Acknowledgement Letter, and the validity period of provisional FiT rates has expired]

Your provisional FiT rates will be invalid. Your FiT rates will follow the prevailing rates published on the CLP website on the day when your RE system is connected to CLP grid.

ii) [If the customer has submitted the required technical documents, but the validity period of provisional FiT rates has expired]

The validity period of your provisional FiT rates will be extended for 4 months from the announcement date of the new FiT rates. Please connect your RE system to the CLP grid on or before the extended expiry date (i.e. 26 August 2022), otherwise your FiT rates will follow the prevailing rates published on CLP website on the day when your RE system is connected to CLP grid.

iii) [If the customer is awaiting CLP's engineering staff to witness the site test of the RE system and/or install the FiT meter, but the validity period of provisional FiT rates has expired]

Your provisional FiT rates will still be valid until your RE system is connected to CLP grid.

iv) [If the validity period of the provisional FiT rates has not yet expired]

The validity period of your provisional FiT rates will be extended for 4 months from the expiry date stated in the Acknowledgment Letter. Please connect your RE system to the CLP grid on or before the extended expiry date, otherwise your FiT rates will follow the prevailing rates published on the CLP website on the day when your RE system is connected to the CLP grid.
