1. Beneficiary Categories:

(Applicants must provide relevant document number, HK Identity card number, and CLP residential customer account number.)		
The beneficiary of all categories must be a Hong Kong resident for not less than one year; and have resided in Hong Kong for at least one year since acquiring the Hong Kong resident status. Those holding visas or recognition forms issued by the Immigration Department are <u>not eligible</u> subsidy programme.		

2. Application Details:

Beneficiary **MUST** be nominated by Power Connect Non-Governmental Organisations (NGOs). All quotas are distributed base on the previous year submission together with his service area and service group. The subsidy will be processed and served with limited quota basis.

3. Document must be provided for application:

- Hong Kong identity card of beneficiary
- Copy of electricity bill (With full display of residential address, English name and CLP electricity account number)
- Eligible and corresponding document number

4. Application Procedure:

- I. All quota of application has been allocated to the designated non-government organization of all districts. Interested persons may contact the NGOs for details.
- II. Beneficiary must be nominated by Power Connect partnered NGOs. Interested persons may contact the NGOs for details.
- III. The eligibility of the applicants will be confirmed by the NGOs and review by CLP.
- IV. One-off subsidy of HK\$1,000 per household will be distributed to successful applicant.
- V. All successful applicants will receive notification via SMS message.

5. Important Date:

- Application period: 3 May 2022 to 31 August 2022
(The subsidy will be processed and served with limited quota basis)
- Expected date of payment: By 31 December 2022

6. Points to note :

- CLP "Power Connect Programme" only accept our partnered NGOs to process and nominate beneficiary's application. Please refer to our [website](#) for the NGOs list.
- CLP must not accept application submitted by unauthorized organization since the application involve in the provisions of the Personal Data (Privacy) Ordinance, and any other data protection law as applicable.
- All applications must be submitted by CLP Power Connect partnered NGOs within the application period. Individual applications are not accepted.
- Even the application form is successful to submit, the application may still fail to apply the subsidy due to the full quota.
- Amendments to the information provided in the application form should be duly signed or chop by NGO.
- All applications are subject to terms and conditions.
